Wednesday, April 2nd 2:00 pm to 5:00 pm - Weigh Scales Inspection – Nash County Farmers Market, 1006 Peachtree Str. Rocky Mount NC 27804
Annual inspection of your weigh scales is required for market participation. An inspector from the NC Department of Agriculture and Consumer Sciences will be at the market to certify the accuracy of your weigh scales. If you do not bring your scales to the market during this time, you will need to make other arrangements to certify your scales for accuracy.
