Nash County Farmers Market, 1006 Peachtree St, Rocky Mount NC 27804

Annual inspection of your weigh scales is required for market participation. An inspector from the NC Department of Agriculture and Consumer Sciences will be at the market to certify the accuracy of your weigh scales. If you do not bring your scales to the market during this time, you must make other arrangements to certify your scales for accuracy.

One-time Payment Offer

Nashville Farmers Market is offering 2026 vendors an opportunity to pay upfront fees for the discounted fee on the payment schedule. Please submit full payment with your 2026 Vendor Certification Form Due March 27, 2026. After this deadline no discount will be applied.
